Membership Categories

General Membership - \$199.50 per month, plus a \$15.00 monthly Irrigation Fee. A Clubhouse food expenditure minimum of \$125.00 per quarter is currently suspended but could be reinstated at any time by the Board of Directors.

A General Membership includes an individual or all members of an immediate household; who consist of the husband, wife, and children through 18 years of age. The individual or immediate household gets full use of all club facilities and amenities. Voting rights are as described in the Club's by-laws.

<u>Introductory Membership</u> - \$157.50 per month, plus a \$15.00 monthly irrigation fee. A Clubhouse food expenditure minimum of \$125.00 per quarter is currently suspended but could be reinstated at any time by the Board of Directors.

An Introductory Membership requires a one-year commitment for an individual or for an immediate household; which consist of the husband, wife, and children through 18 years of age. The individual or immediate household gets full use of all club facilities and amenities. There are no voting rights with an Introductory Membership. Any previous member, who wants to reapply for membership, is not eligible to reapply under the Introductory category unless five years has passed since the previous membership expired.

Business/Corporate Membership - \$369.50 per month, plus a \$15.00 monthly irrigation fee. A Clubhouse food expenditure minimum of \$125.00 per quarter is currently suspended but could be reinstated at any time by the Board of Directors. A Business/Corporate Membership includes two (2) Designated individual or immediate household memberships annually with one member being the Principal member.

The Designated member(s) may change on an annual basis. An immediate household includes the husband, wife, and children through 18 years of age. The individual or immediate household members get full use of all club facilities and amenities. Employees of the Business/Corporate membership may make one tee time per day, AM or PM, for up to four people and will be charged discounted greens fees and cart rental fees. Employees may use a designees' membership for payment of these fees with the designees' written permission. The Principal member only has voting rights as described in the Club bylaws. Recognition of the business/corporation in Club materials, cart rental, etc. is not included but available.

Advertising Membership - \$220.50 per month.

An Advertising Membership includes one designated individual annually. The designated member may change on an annual basis. Advertising for this category can be displayed in the Pro Shop or on the golf course and in the monthly newsletter. Advertising members may play golf as any member of the public is allowed. There are no voting rights with an Advertising Membership.

Non-resident General Membership - \$105.00 per month, plus a \$15.00 monthly irrigation fee. A Clubhouse food expenditure minimum of \$125.00 per quarter is currently suspended but could be reinstated at any time by the Board of Directors.

A Non-resident General Membership requires an individual or all members of an immediate household, which includes the husband, wife and children through the age of 18, to reside more than 60 miles from the Club. The individual or immediate household gets full use of all club facilities and amenities. Voting rights are as described in the Club's bylaws.

Social Membership - \$38.50 per month.

A Social Membership includes one individual member. The member may attend all social functions and gets full use of the swimming pool

and locker rooms. A Social Member may play golf as any member of the public is allowed. There are no voting rights with a Social Membership.

Corporate-Social Membership - \$50.00 per month.

A Corporate-Social Membership includes one designated individual member. The designated member may change on an annual basis. The member may attend all social functions and gets full use of the swimming pool and locker rooms. A Social member may play golf as any member of the public is allowed. There are no voting rights with a Social Membership.

College Membership - \$259.50 per year.

A College Membership includes an individual enrolled full-time in an institution of higher education and be under the age of 26. The individual member gets full use of all club facilities and amenities. There are no voting rights with a College Membership.

Junior membership - \$157.50 per year.

A Junior Membership includes an individual who enrolls prior to their 19th birthday. Enrollment is for a one year period from their enrollment date. The individual member must have an established handicap to play before noon on weekends and holidays. The individual member gets full use of all club facilities and amenities. There are no voting rights with a Junior Membership.

<u>Barter Membership – Annual contribution.</u>

A Barter Membership includes an individual who must make an annual contribution to the Club equal to or better than the cost of a General Membership. The individual gets full use of all club facilities and amenities. Voting rights are as described in the Club's by-laws.

Important Notes:

A member of any of the following categories; General Membership, Business/Corporate, Non-resident, College, Junior, or Barter who

resigns, loses all playing privileges for one year, including playing as a guest or member of the general public. This includes an individual or an immediate household as defined.

All Memberships applications are subject to Board approval.

Prices of memberships are subject to change as determined by the Board of Directors.

Initiation fees have been suspended but could be reinstated at any time by the Board of Directors.
