# **The Dalles Country Club**

# **Membership Categories/Policies**

### 6-29-2023

# <u>General Membership</u> - \$199.50 per month, plus a \$15.00 per month irrigation assessment.

A Clubhouse food expenditure minimum of \$125.00 per quarter and the initiation fee are currently suspended but could be reinstated at any time by the Board of Directors. The Applicant must deposit a sum of not less than the established initiation fee and one month of dues and fees at the time of submission of that application. The membership 'anniversary date' will be the first day of the month following the application date.

A General membership includes the Applicant and all members of the immediate family. An immediate family consists of the applicant, spouse or domestic partner, and children and dependents through 18 years of age. The Applicant and immediate family have full use of all Club facilities and amenities. A General membership has one vote on Club matters.

General members may convert their membership to a Social or Social-Plus membership at any time. The new Social or Social-Plus anniversary date will start on the first of the month following the date on which the conversion application was submitted. However, the Social or Social-Plus member cannot convert back to General membership within a one-year period, starting on the Social or Social-Plus anniversary date, unless the difference between what was paid as a Social or Social-Plus member and a General member is first paid from the time of the conversion anniversary date. After a one-year period of conversion from General to Social or Social-Plus, the member may convert back to a General member without any dues owed.

A General member who resigns their Club membership altogether cannot become a General member again within one year unless all back dues are paid for that one-year period, starting on the anniversary date of their dropped membership. A General member who resigns their membership altogether cannot become a Social or Social-Plus member within one year unless all back dues are paid for what would have been paid as a Social or Social-Plus membership for that one-year period, starting on the anniversary date of their dropped membership.

A General member may resign their Club membership altogether at any time. The dropped membership anniversary date starts on the first of the month following the date on which their resignation was submitted. Resigned Club members will be allowed to play immediately upon acceptance of their resignation under the same Club policies that any non-member may play, without having to wait for a one-year period.

# <u>Corporate Membership</u> - \$378.00 per month, plus a \$15.00 per month irrigation assessment.

A Clubhouse food expenditure minimum of \$125.00 per quarter and the initiation fee are currently suspended but could be reinstated at any time by the Board of Directors. The Applicant must deposit a sum of not less than the established initiation fee and one month of dues and fees at the time of submission for that application. The membership 'anniversary date' will be the first day of the month following the application date.

A Corporate membership includes a Principal employee and one Associate employee and their immediate families. An immediate family consists of the employee, spouse or domestic partner, and children and dependents through 18 years of age. The designated Principal member and Associate member may change on an annual basis. Both members get full use of all club facilities and amenities. Any other employee earning more than 50 percent of their income from the corporation, may make one tee time per day for up to four employees of that corporation. A 10 percent discount on greens fees will apply. Employees may use a designee's membership for payment of these fees with the designee's written permission. The Principal member only has voting rights as described in the Club's by-laws. Recognition of the corporation in Club materials, cart rental, etc. is not included but available.

### Advertising Membership - \$210.00 per month.

A Clubhouse food expenditure minimum of \$125.00 per quarter and the initiation fee are currently suspended but could be reinstated at any time by the Board of Directors. The Applicant must deposit a sum of not less than the established initiation fee and one month of dues and fees at the time of submission of that application. The membership 'anniversary date' will be the first day of the month following the application date.

An Advertising membership includes one designated individual annually. The designated member may change on an annual basis on the anniversary date. Advertising for this category can be displayed in the Pro Shop or on the golf course and in the monthly newsletter. Advertising members may play golf as any member of the public is allowed. There are no voting rights with an Advertising membership.

## Social and Social-Plus Memberships

### Social - \$50.00 per month, per person.

A Clubhouse food expenditure minimum of \$125.00 per quarter and the initiation fee are currently suspended but could be reinstated at any time by the Board of Directors. The Applicant must deposit a sum of not less than the established initiation fee and one month of dues and fees at the time of submission of that application. The membership 'anniversary date' will be the first day of the month following the application date.

Social members will receive the same discounts on food and beverages and Golf Shop purchases as General members receive. They also get the use of the Club's pool but do not have golfing or voting rights. If Social members want to play golf, they can book tee times and be charged under the same policies as any other non-member. Social members may play in Club tournaments if they have an established handicap. Social members, who were not previously General members or Social-Plus members within a year period, may convert to a General or Social-Plus membership at any time. The General or SocialPlus membership anniversary date will start on the first of the month following the date on which the application was submitted.

# Social-Plus - \$50.00 per month, per person, plus a \$15.00 per month irrigation assessment.

A Clubhouse food expenditure minimum of \$125.00 per quarter and the initiation fee are currently suspended but could be reinstated at any time by the Board of Directors. The Applicant must deposit a sum of not less than the established initiation fee and one month of dues and fees at the time of submission of that application. The membership 'anniversary date' will be the first day of the month following the application date.

Social-Plus members will get the same benefits as Social members and will get a 15 percent Social-Plus discount on each round of golf they play. This 15 percent discount will be deducted from the non-member greens fee rate only, as it is set throughout the year. There is no limit on the number of rounds that a Social-Plus member is allowed to play. The 15 percent discount will be deducted when paying in the Golf Shop or charged on their monthly billing statement. Social-Plus members may play in Club tournaments if they have an established handicap. Social-Plus members, who were not previously General members within a one-year period, may convert to a General or a Social membership at any time.

#### College Membership - \$259.00 per year.

The Applicant must deposit a sum of not less than the established initiation fee, currently suspended, and one year of dues and fees at the time of submission of that application. The membership 'anniversary date' will be the first day of the month following the application date.

A College membership includes an individual enrolled full-time in an institution of higher education, including trade schools, and be under the age of 26. The individual member gets full use of all club facilities and amenities. There are no voting rights with a College membership.

#### Junior membership - \$157.50 per year.

The Applicant must deposit a sum of not less than the established initiation fee (currently suspended) and one year of dues and fees at the time of submission of that application. The membership 'anniversary date' will be the first day of the month following the application date.

A Junior Membership includes an individual who enrolls prior to their 19<sup>th</sup> birthday. Enrollment is for a one year period from their enrollment date. The individual member must have an established handicap to play before noon on weekends and holidays. The individual member gets full use of all club facilities and amenities. There are no voting rights with a Junior Membership.

#### **Barter Membership – Annual contribution.**

A Barter Membership includes an individual who must make an annual, inkind contribution to the Club equal to or better than the cost of a General membership. A monthly calculation will be made as to the sufficiency of the in-kind contribution. The Club will provide a 1099 IRS form at the end of the calendar year. The individual gets full use of all club facilities and amenities. Voting rights are as described in the Club's by-laws.

#### **Important Notes:**

All Memberships applications are subject to Board of Directors approval.

The fees and assessments of all memberships are subject to change as determined by the Board of Directors.

Initiation fees have been suspended but could be reinstated at any time by the Board of Directors.

A Clubhouse food expenditure minimum of \$125.00 per quarter is currently suspended but could be reinstated at any time by the Board of Directors.

Cart owners shall not lease or let non-cart owners use their golf carts. No more than two parties may share a cart. Dual ownership is allowed.

Medical leave of absence is optional for a General or Corporate member. However, upon approval of a medical leave of absence, that membership is converted to a Social membership for that person only. Any immediate family member will no longer have the benefits of the General or Corporate membership and can only play golf as any non-member is allowed.

The Grill, Steak and Seafood Restaurant in the Clubhouse is open to the public. Club members <u>only</u> get a 10 percent discount on food and beverages. Guests of Club members do not get restaurant discounts.
